CONSIDER RESIGNATION OF POLICE OFFICER NICHOLAS ONDO AND REQUEST THE BOROUGH CIVIL SERVICE COMMISSION BEGIN THE PROCESS OF ESTABLISHING THE ELIGIBILITY LIST FOR HIRING A NEW POLICE OFFICER

- Chief Osborne explained that Officer Ondo was hired in 2004 and that his last day with the Borough would be on 9/14/22. Chief Osborne expressed his regret with seeing Officer Ondo leave. Chief Osborne expressed his concerns with getting enough qualified candidates through the Civil Service Process as he has heard that other departments are struggling to find people.
- Mr. Scott Jaillet moved to accept the resignation of Police Officer Nicholas Ondo with regret and request that the Borough Civil Service Commission begin the process of establishing the eligibility list for hiring a new police officer. Ms. Amy Gallagher seconded the motion and it carried unanimously.
